

Grace Chapel Guest Network Policy

The following is the policy that all users of the Grace Chapel Guest Network must accept and follow in order to use the service:

Grace Chapel Guest Network

This service provides Grace Chapel visitors with Internet access external to Grace Chapel.

BY ACCESSING THE GRACE CHAPEL GUEST NETWORK, YOU AGREE TO THE FOLLOWING TERMS AND CONDITIONS. IF YOU DO NOT AGREE TO THE FOLLOWING TERMS AND CONDITIONS, THEN DO NOT ACCESS OR USE THE GRACE CHAPEL GUEST NETWORK.

1. The Grace Chapel Guest Network is for use by authorized Grace Chapel visitors only.
2. ANY UNAUTHORIZED ACCESS OR USE IS STRICTLY PROHIBITED.
3. No Grace Chapel-owned desktops, laptops, servers or other devices may be connected to the Grace Chapel Guest Network for any reason without written approval from Grace Chapel's Technical Services Group ("TSG").
4. Grace Chapel may monitor and record network activity and anyone accessing or using the Grace Chapel Guest Network expressly consents to such monitoring and recording. Therefore, the use of the network should not be considered private. If Grace Chapel detects inappropriate use it may be reported to Grace Chapel management and/or law enforcement agencies.
5. The Grace Chapel Guest Network is provided strictly as a convenience to authorized users. Access and use is not guaranteed and may be terminated at any time without notice in Grace Chapel's sole discretion.

Individuals accessing or using the Grace Chapel Guest Network do so at their own risk and are solely responsible and liable for any and all risks of accessing the Grace Chapel Guest Network, including without limitation the risk that other users could attempt to access the user's pc, laptop or other device connected to the network. Users should ensure that they have installed and active up-to-date operating systems, Internet browsers, virus, anti-spam, firewall and other protective software and hardware.
